**RULES AND REGULATIONS OF THE 4th 20 SECONDS OF HORROR MOVISTAR+ VIDEO CONTEST**

**Registration and selection**

1. The videos to competition must belong to the horror genre in whichever sub-genre, extension or interpretation.
2. The videos must be published on Twitter, Facebook or Instagram with the hashtag #20SegundosMovistar. The post must include the title of the work.
3. The videos must be inserted on Twitter, Facebook or Instagram, and no external links will be admitted.
4. Videos to competition must have been published after May 23th 2018 and before October 31th 2018.
5. Users inscribing one or more videos to competition must be followers of the Festival's account of the social network in which they publish it just in case it was necessary to contact them through the same network.
6. The Jury will choose the nominees as well as the winner out of all the works presented which satisfy these conditions.
7. The Festival and Movistar+ will hold the right to screen or publish the videos. With their participation in the contest, the authors are giving their implicit consent.

**Jury and prizes**

1. The Festival will choose the members of the Jury. This Jury will decide on the three nominees which will be announced next November 5th, 2018 as well as a winner that will be announced in the Movistar session during the Festival.
2. The videos in competition will opt to the following prizes:
  - One full access ticket to the whole Festival for the three nominees, screening of their works during the Festival as well as their distribution through Movistar+'s networks.
  - The three nominees will get 3 six month subscriptions to Movistar+ (one each) entitling them to access to all the contents of the platform (cinema, tv series, soccer and other sports, Premium channels).
  - The winning short film will be entitle for a 2 night hotel stay for two nights in a double room, for the nights of November 17th and 18th.
  - The winning short film will also get a premium pack of Festival merchandising, and a special pack of Blu-ray films.

• The three nominees will be screened during the Movistar Session and the winner will be screened on November 17th as well, before the closing screening of the festival.

3. Prizes cannot be declared ex-aequo.
4. Prizes can be declared null and void if the Jury decides on it.
5. The jury will hold the right to concede special mentions to the videos in competition.

**General dispositions**

1. The scope of the competition is international.
2. You can inscribe as many videos as you like, but they must have a maximum 20 second length (excluding title and credits, if any).
3. The videos must be framed within any extension or interpretation of the horror genre.
4. Contestants will respond that their video does not damage the rights of third persons. The organization will remain exempt of any responsibilities.

**Final dispositions**

1. Participating in the Contest includes complete acceptance of its rules and regulations.
2. The organization of the Festival will take the last decisions in any eventuality.
3. The organization holds the right to change the rules and regulations without previous notification.
